INFORMATION FOR MEETINGS DURING AN OFFICIALLY DECLARED STATE OF EMERGENCY UNDER ASSEMBLY BILL 361 (effective until the state of emergency is lifted by the Governor):

Pursuant to California Assembly Bill 361, a local legislative body is authorized to hold public meetings via teleconferencing and to make public meetings accessible telephonically or otherwise electronically to all members of the public seeking to observe and to address the local legislative body during the current health emergency. As such, the Planning Commissioners will be participating in the Planning Commission meeting via teleconference, and the Commission will provide various options for the public to participate in the conduct of the meeting remotely.

The Commission will further adhere to the means otherwise prescribed by the Brown Act, which allows members of the public the right to observe and offer public comment during the public meeting, consistent with the public's rights of access and public comment otherwise provided for by the Brown Act, as applicable (including, but not limited to, the requirement that such rights of access and public comment be made available in a manner consistent with the Americans with Disabilities Act).

In addition to the mandatory conditions set forth above, the Commission will use sound discretion and make reasonable efforts to adhere as closely as reasonably possible to the provisions of the Brown Act, and other applicable local laws regulating the conduct of public meetings, in order to maximize transparency and provide the public access to their meetings.

The Commission offers many ways for you to watch and participate in Planning Commission matters without attending a meeting in-person.  - 8.1 **[The Lab Master Sign Program \(SIGN22-009\)](#) – Consideration of a Major Sign Permit for a Master Sign Program for multi-tenant and building signage for The Lab, located at 4383 Horton Street fronting Horton Street and Sherwin Avenue. CEQA Status: This project is exempt from environmental review under State CEQA Guidelines Section 15311(a) which applies to placement of on-premises signs, and the “common sense exemption” at Section 15061(b)(3) because it can be seen with certainty that there is no possibility that the proposal may have a significant effect on the environment. General Plan Land Use Classification: Mixed Use with Residential; Zoning District: Planned Unit Development (PUD-7) and Park Avenue District Overly (P-A) (Applicant: Stephen Kelley, Clear Sign & Design) (Owner: Steelwave LLC) (APN:49-1557-6)**
 - 8.2 **[Tree Removal, 5980 Horton Street \(TREE22-001\)](#) – Consideration of a Tree Removal Permit for a single London Plane tree located at 5980 Horton Street fronting 59th Street. Removal of the tree is proposed in order to enlarge an existing loading area. CEQA Status: This project is exempt from environmental review under State CEQA Guidelines Section 15301(c), which applies to minor alterations to existing streets, sidewalks, and similar facilities; and the “common sense exemption” at Section 15061(b)(3) because it can be seen with certainty that there is no possibility that the proposal may have a significant effect on the environment. General Plan Land Use Classification: Office/Technology; Zoning District: Office/Technology (OT) and North Hollis Overly (NH) (Applicant: Roland Lazzarotto) (Owner: Wareham Development Group) (Adjacent to APN:49-1489-17)**

- 9.1** [4300 San Pablo Intergenerational Affordable Housing \(ZC22-001\)](#) – A second study session to review a proposal for redevelopment of a 0.47-acre site at 4300 San Pablo Avenue with a 5-story, 68-unit, 100% affordable intergenerational housing project with ground floor amenity and community space. The applicant proposes that the project be processed under SB 35, which mandates ministerial approval (i.e. staff level), and AB 1763, which specifies no density limit for projects within one-half mile of transit. General Plan Land Use Classification: Mixed Use with Residential, Major Transit Hub, and Neighborhood Retail Overlay; Zoning District: Mixed Use with Residential (MUR), Neighborhood Retail Overlay (NR), Transit Hub Overlay (TH), and Pedestrian Priority Zone (PP) (Applicant: EAH Inc.) (Owner: City of Emeryville) (APNs: 49-1079-14-1 and -17-1)
- 9.2** [Christie Avenue Mixed Use Project \(UPDR22-001\)](#) – A second study session to review a proposed mixed-use project on a 3.76-acre site at 5801-5861 Christie Avenue, including a 12-story, 164-foot high residential tower with 94 units, a 13-story, 202-foot high commercial tower with approximately 425,100 square feet of research and development and office space, and a parking area accommodating 566 parking spaces. The project will include a new half-acre public park fronting Christie Avenue and will demolish all existing buildings on the site. General Plan Land Use Classification: Mixed Use with Residential, Major Transit Hub, and Other Park Opportunity; Zoning District: Mixed Use with Residential (MUR), Transit Hub Overlay (TH), and Pedestrian Priority Zone (PP) (Owner/Applicant: 5801 Christie Owner (DE) LLC c/o Oxford Properties Group) (APNs: 49-1494-3-2 and -4-8)
- 9.3** [Prohousing Designation \(STUDY22-002\)](#) – Review of application requirements prior to submittal to the State Housing and Community Development Department (HCD) for the Prohousing Designation Program, which provides incentives to cities in the form of additional points or other preferences for competitive funding programs for transportation infrastructure, housing, or other amenities.
